In view of the upcoming holidays and student-demand, the last date of Spot-round for Admission to Four-Year Undergraduate Programs (FYUGP) / Integrated P.G. Programs with multiple-exit options for the Academic Session 2025-2026 is hereby extended as detailed below:

1	<p><b>Spot-Round for CUET COLLEGES (Listed in Annexure A &amp; C) as well as For NON-CUET COLLEGES (Listed in Annexure B) for Leftover seats</b></p> <ul style="list-style-type: none"> <li>The interface for registration and selection of programs and colleges shall remain available on the Samarth Portal, enabling aspirants to apply for spot admissions. All eligible candidates interested in participating in the Spot Round are required to complete the Registration and College/Program selection within the stipulated timeline. Candidates are advised to follow the instructions issued by the respective colleges on their college websites.</li> <li>Colleges shall grant admission as per the following criteria: <ul style="list-style-type: none"> <li>Wherever more than 30% seats of a major subject were vacant on 31-07-2025, the colleges shall continue admitting students to such major subjects on First-Come-First-Serve basis.</li> <li>Wherever less than 30% seats of a major subject were vacant on 31-07-2025, the college shall consolidate their vacancy positions and admit students strictly by framing a merit list of the applicants on the basis of 10+2 marks. The merit-list publication and admission schedule should be duly published on the college website.</li> </ul> </li> <li>Candidates who have not registered in previous rounds owing to late declaration of result or due to any other issue, can also register during this period and apply for admission to various colleges.</li> <li>All admission coordinators shall ensure that the fee link is activated immediately after the verification so that candidates get time to pay fee.</li> <li>Candidates who had been allotted colleges in any previous rounds but had been unable to complete admission formalities due to non-payment of fee, missing deadlines or any other issues, can visit the colleges allotted to them in previous rounds and complete their admission formalities.</li> </ul>	Up to 14th August, 2025 5.00 PM
2	<b>Completion of Admission Formalities including payment of Fee</b>	Up to 18th August 2025
3	<p><b>Shifting of students for Majors with Low Enrollment</b></p> <p>In case the number of admissions in a particular major falls below the prescribed limit set by JKHED, the students shall be shifted to another college/major.</p>	19 <sup>th</sup> to 20 <sup>th</sup> August, 2025
4	<b>Completion of Admission Process</b>	20th August 2025
